

## BID NOTICE UNDER OPEN DOMESTIC BIDDING

The Uganda Electricity Distribution Limited has allocated funds for Supply of post-paid energy meters (KVA 3-phase energy meter complete solution with current transformers (CTs) and Combined CTVT metering Unit and HT energy meter complete with meter box under a framework contract for a period eighteen months for a period of eighteen months.
2. The Entity invites sealed bids from eligible bidders for supply of the above.
3. Bidding will be conducted in accordance with the open domestic bidding method contained in the Public Procurement and Disposal of Public Assets Act, 2003, and is open to all bidders.

Bid security must be valid until **30<sup>th</sup> July 2023**. Late bids shall be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below at 7 (d) **at 11.30am 14<sup>th</sup> December 2022**. There shall be no pre – bid meeting.
