

BID NOTICE UNDER OPEN DOMESTIC BIDDING



Supply of prepaid energy meters (split single phase smart wired energy meters with CIU complete solution, 3-phase wired split ordinary energy meters (100A) complete solution and split High current wired 3-phase energy meters (250A) complete solution) under a framework contract for a period eighteen months.

The Uganda Electricity Distribution Limited has allocated funds for supply of prepaid energy meters (split single phase smart wired energy meters with CIU complete solution, 3-phase wired split ordinary energy meters (100A) complete solution and split High current wired 3-phase energy meters (250A) complete solution) under a framework contract for a period eighteen months.
2. The Entity invites sealed bids from eligible bidders for supply of the above.
3. Bidding will be conducted in accordance with the open domestic bidding method contained in the Public Procurement and Disposal of Public Assets Act, 2003, and is open to all bidders.

6. Bids must be delivered to the address above at 7 (c) at or before **14th December 2022, 11:00 am**. All bids must be accompanied by a bid security of **UGX.10,000,000**. Bid security must be valid until **30th July 2023**. Late bids shall be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below at 7 (d) **at 11.30am 14th December 2022**. There shall be no pre – bid meeting.
